In reference to your above mentioned letter where approval for above referred proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The geo coordinates of all key points to define the shape of proposed forest land for diversion has not been provided.
2. The information regarding justification for locating the Project in forest land has not been provided.
3. The area calculation sheet for proposed forest land is incorrect. The area calculation for curved portion is incorrect.
4. NPV calculation shall be based on correct calculation for proposed forest land for diversion.
5. The compensatory afforestation scheme for the proposal does not conform to the section 3.2 of the Handbook of FCA-1980 guidelines (2003). The same needs revision.
6. The online proposal is without following documents/certificates:
  - a. Site Inspection Report of DFO.
  - b. Certificate regarding Van Swaroop Land
  - c. Certificate regarding Protected Area
  - d. Certificate of user agency regarding NPV and compensatory afforestation
