Sir,

Kindly refer to the online proposal of Government of Himachal Pradesh on the above-mentioned subject seeking approval of the Central Government for diversion of **6 ha** of forest land for non-forestry purpose for **Construction of Eklavya Model Residential School** in accordance with section 2 of the Forest (Conservation) Act, 1980.
