Sub: Proposal for diversion of 0.45 ha for 2 laning of Peren-Jalukie section on NH 129A on Engineering, Procurement and Construction Mode in the state of Nagaland.

Ref: (i)Online proposal No. FP/NL/ROAD/122964/2021.

Sir,

Please refer the State Govt online proposal No. FP/NL/ROAD/122964/2021 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and following lacking information/documents has been observed: -

1. To clarify whether this proposal is for new construction of road or else, provide a brief note on the existing stretch of the road to be improved/widened whether the forest clearance of such road has been granted earlier or not.
2. To clarify the legal status of the proposed area as the DFO in his site inspection report has mentioned that the proposed alignment of NH-129A is passing through the "purchased land" of Forest Department under Paren Forest Division for a stretch of about 450 meters along the existing Peren -Jalukia road.
3. The SoI Map indicating the proposed area is to be resubmitted as the proposed area is falling outside the submitted SoI map .
4. State Govt is to clarify the actual CA area proposed as the CA area is proposed in 0.45 ha in Forest Colony in Peren Range, in purchased land whereas the submitted SoI map indicating the proposed CA area is for 0.9 ha and the financial outlay submitted is for 0.9 ha i.e. Rs 1.575 lacs.
5. The CA scheme and avenue plantation scheme is to be technically approved and duly signed by the competent authority.
6. The component wise break up of the proposed road.
7. The current status of FRAct,2006 certificate of this instant proposal.
8. To clarify whether the proposed muck dumping area is the part of the proposed area or not.
9. The total length of the proposed road along with existing RoW and proposed RoW.
10. The approved muck dumping plan by the concerned DFO.



11. The aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Park.
12. Undertaking certificate by the user agency for payment for extraction charges of the trees to be removed from the propose area.

The DSS report on the proposed area and CA area is awaited from the FSI, Dehradun and shall be communicated, if required.

State Govt is requested to kindly furnish the above information to this office for further processing of this proposal.
