Sub: Proposal for diversion of 23.983 ha of revenue forest land for construction of 220 KV LILO from existing 220 KV of Bhanjanagar-Meramundali DC line to 220/33 KV Grid Sub-Station at Daspalla from village Madhyakhanda to Gopalpur by M/s OPTCL under Daspalla Tahasil of Nayagarh district under Nayagarh Forest Division (Proposal No.FP/OR/Trans/146005/2021, State Serial No.OR-074/2021 dated 17.09.2021)

Ref: Your office Memo No.105 dated 10.01.2023

In inviting reference to your aforesaid office memo on the captioned subject, this is to inform you that during the course of checking of the above proposal the following discrepancies have been noticed.

- (i) Form 'A' Part-I needs correction as area for Forest & Non-forest is not tallying.
- (ii) In Form-A, Part-II furnished by the DFO, Nayagarh Division at Sl. No.(vi)- the canopy density of the proposed forest land for diversion has not been mentioned for calculation of NPV.
- (iii) (a) In the detailed note of the project, the UA has not furnished the three alternative routes surveyed for laying of transmission line and the parameters of selection of final route.
 - (b) The UA has also not furnished three alternative routes surveyed and shown on the topomaps duly countersigned by both the DFO & Tahasildar concerned.
- (iv) Regarding involvement of total 80.226 ha of non-forest land in 19 villages required for the project under Daspalla Tahasil of Nayagarh District, the village wise the break-up of non-forest Govt. and non-forest Pvt. land, separately duly countersigned by the DFO & the Tahasildar concerned has not been furnished.
- (v) (a) Undertaking for SSWLCP by the UA is required as per Site Inspection of DFO, Nayagarh.
 - (b) Distance of proposed laying of transmission line from ESZ of Baisipalli Sanctuary is to be shown on a map.

(vi) Tree Enumeration:- Total 6736 Nos. of trees has been enumerated both over forest and non-forest land involved in the project. But the UA has not furnished village wise tree enumeration list separately over forest and non-forest (Govt. and Pvt.) land. Also, the species and girth class wise abstract of the trees enumerated over forest land, non-forest Govt. and non-forest Pvt. land is to be submitted by UA, duly countersigned by DFO and Tahasildar concerned.

In view of the above, the diversion proposal in triplicate are returned herewith for necessary compliance at your end and resubmission of the same to this office at the earliest for taking further necessary action at this end.
