Sub.: Improvement / Widening of Nanau-Dadau Road (MDR 82W) (0.000km to 30.000km) for proposed protected forest diversion of 10.184 ha with felling of 1434 trees-reg.

Ref: P-190/14-2-2016-800(194)/2016 dated 3rd January 2017

Sir,

In reference to your above mentioned letter where approval for the above referred proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. As per the GIS DSS analysis, the .kml files (online uploaded ones) of proposed forest land diversion are in line format instead of polygon format.
2. The proposal is without submission .kml files for proposed forest land diversion and proposed compensatory afforestation have not been submitted in form of CD with hard copy of the proposal.
3. The land schedule provide from page 38 to 39 does not provide for balance of RoW at various chainage. Why varying width has been adopted at various chainages has not been explained in the proposal.
4. The map uploaded of proposed forest land diversion is not a geo referenced map providing key points geo co ordinates.
5. The data employment generation shows 1500 nos as permanent employment which appears to be incorrect.
6. The certificate under FRA 2006 from DM Aligarh is not as per format and needs revision.
7. These discrepancies need rectification:
 - (a) The enumeration list provided with the proposal mentions 1,434 nos whereas online uploaded list sums up to 1,435 nos.
 - (b) Details of poles (gbh < 30 cms) and plants in proposed forest land has not been provided.
8. The kml files for compensatory afforestation needs submission for GIS DSS analysis.
9. The proposal is without following documents uploaded online:
 - a. Site Inspection Report of DFO in GOI approved format.

b. Site suitability certificate for compensatory afforestation.

Therefore, the original proposal is hereby returned for rectification/revision of the same as per the observations made above in point wise manner.

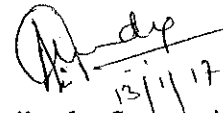

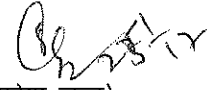
