विषय:-Diversion of 3.0835 ha of forest land in favour of Rural Development Department for the construction of Kathiyan to Dirnad Motor Road under PMGSY in Distt. Dehradun, Uttarakhand. (FP/UK/ROAD/34380/2018)

सन्दर्भ:—अपर प्रमुख वन संरक्षक एवं नोडल अधिकारी, वन संरक्षण, उत्तराखण्ड का पत्रांक – 1327 / FP/UK/ROAD/34380/2018 दिनांक 02-12-2019

महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. CA site suitability certificate is not found uploaded. State Government may upload the CA site suitability certificate.
- 2. Name of proposal is not mentioned in authority letter. State Govt. may mention the name of proposal and upload/submit the same at para-A-3 (xvii) of Part-I.
- 3. On perusal of KML file, starting point of the proposed road is not connecting with any road. The proposed alignment in the starting going through reserve forest area however plenty of non forest land available parallel to the road. State Govt. may submit the justification in this regard.
- 4. It is seen from KML file of the proposed road that the end point of the road is connected to an existing road. The location Dirnad shown in KML file is also seen connected to an existing road. Hence, the third connectivity that too involving 1.645 of RF land doesn't appear to be justified. State Govt. may submit the clear justification in this regard.
- 5. उपरोक्त के अतिरिक्त लाभान्वित ग्राम एवं existing roads network को भी KML file पर अंकित कराया जाये ।
- 6. Shape of KML file and digital map of CA area are not matching. State Govt. may correct the same and submit/upload the revised digital map in original.
- 7. CA scheme is prepared for Rs. 14,69,292/- but in the last para Rs. 17,18,527/- @ approved rate mentioned. State Govt. may prepare the CA scheme for Rs. 17,18,527/-
- 8. State Govt. may submit the tree enumeration list in original copy.

- 9. Non forest land identified for muck disposal has not been added in the village-wise breakup in para-B-2.3. State Govt. may upload the correct information in para-B-2.3 of Part-I.
- 10. In para-B-2.4 (Component wise breakup) the non forest land required for muck disposal is mentioned as 0.597 ha but the area of non forest land for muck disposal comes to 0.56 ha in one document and 1.57 ha in the other document of muck disposal plan submitted in hard copy. State Govt. may clarify the discrepancy and may submit/upload the correct information.
- 11. Justification for locating project in forest land uploaded at para-D(i) of Part-I is not satisfactory. Moreover, the alternate alignment is shown along proposed alignment that too over half of the length only which is also not satisfactory. State Government may submit/upload the clear justification of the proposed road at para-D(i) of Part-I and also submit the justification regarding alternate alignment as it is shown along the proposal alignment.
- 12. In para-4(i) of Part-II, Eco class is mentioned as Eco class-V but is likely to be eco class-VI. State Govt. may upload the correct information in this regard.
- 13. In para-14 of Part-II, CA stipulated is not commensurate to forest land diverted. State Govt. may provide correct information at para-14 of online Part-II in district profile.
