Kindly refer to the online proposal of Government of Himachal Pradesh on the above-mentioned subject seeking approval of the Central Government for diversion of 6 ha of forest land for non-forestry purpose for Construction of Eklavya Model Residential School in accordance with section 2 of the Forest (Conservation) Act, 1980.

In the instant proposal, the total area required is 6 ha, which is not according to the prescribed norms as per Para 11.11 of the Handbook of the Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003(Guidelines and Clarification).
