- Divisional Forest Officer need to upload the updated Compensatory Afforestation Scheme as per Model Compensatory Afforestation Scheme prescribed by Nodal Officer (FCA) vide Circular No. PCCF/FCA/1119/6086-6131; Dated: -27/03/2021 and circulated to all Divisional Forest Officers vide this office communication No. FD/CFN/FCA/2102-05; Dated: - 29/03/2021.
- 2. Wildlife Warden Kashmir North Division needs to upload **Compensatory Afforestation Scheme Approval**" from competent authority.
- 3. Any proposal submitted by DCF/DFO seeking prior approval under FCA-1980 shall have a comprehensive scheme for compensatory Afforestation duly approved by the competent authority of the concerned State/UT administration.
- 4. Wildlife Warden Kashmir North Division need to upload Land Suitability certificate regarding area proposed for CA (degraded forest land/ non- forest land) suitable from management point of view, as per format (already communicated to you vide this office No. FD/CFN/2020-21/FCA/1580-85, dated: 14/01/2021.)
- 5. Wildlife Warden Kashmir North Division needs to upload correct Georeferenced map of forest land (Degraded Forest Area) proposed for Compensatory Afforestation.
- 6. **KML of CA** uploaded by Wildlife Warden Kashmir North Division is not showing any area; need to replace with correct one.
- 7. Copy of **Survey of India Toposheet** indicating boundary of the forest land proposed for CA uploaded on PARIVESH Portal is showing alignment of proposed road, need to replace it with correct Toposheet showing proposed CA site.
- 8. Wildlife Warden Kashmir North Division, need to **upload NPV calculation and NPV payment undertaking** duly signed by both PMGSY & Wildlife Warden Kashmir North Division.

- Wildlife Warden Kashmir North Division, need to upload C.A. calculation and C.A. payment undertaking duly signed by both PMGSY & Wildlife Warden Kashmir North Division.
- 10. Wildlife Warden Kashmir North Division, need to upload "Certificate for Minimum Use of Forest Land" as per prescribed format.
- 11. The User Agency has uploaded the KML of the road showing two different colours, but need to added description indicating Private land and Forest Land.
- 12. FRA letter addressed to District Development Commissioner regarding "process of recognition & vesting of Forest Rights in accordance to FRA-2006". User agency need to do few corrections {(i) the letter need to be addressed to District Collector or Deputy Commissioner instead of District Development Commissioner. (ii) the extent of forest area mentioned in the letter need to be corrected & (iii) the corrected FRA correspondence letter need to be uploaded on its designated place on PARIVESH Portal i.e., FORM-A, PART-I Serial No. K.
- 13. The User Agency need to upload ideal layout map for construction/ improvement of roads in UT of Jammu & Kashmir and Ladakh.

The proposal is returned to your office for necessary corrections and uploading of essential documents/ details as prescribed above.
