Adverting to the reference 3rd cited, the additional information submitted in respect of the subject proposal has been examined and observed the following short-comings.

- 1. As seen from the documents uploaded in the PARIVESH portal by the user agency and the DFO, Kurnool, the user agency is seeking approval for rediversion of forest area diverted over an extent of 20.13 ha. The DFO, Nandyal has not reported for how much extent of forest area the user agency is seeking approval for re-diversion. However, the DFO, Nandyal has reported the trees to be felled in re-diversion area of 14.39 ha. In the site inspection report of the DFO, Kurnool, it was mentioned that, the user agency has already taken over 19.301 ha of forest land in Panyam RF, Kurnool Division for conversion of metre gauge railway line to broad gauge line between Giddalur and Dronachalam Stations. It is requested to clarify for how much extent the user agency is requesting for re-diversion.
- 2. The user agency has not uploaded the authenticated maps of the forest area required for re-diversion in Part-I, provide by the IT wing of this office.
- 3. The user agency has not uploaded the kml file of the forest area required for re-diversion in PART-I information.
- 4. The DFO, Kurnool has uploaded the authenticated map of the re-diversion area of 14.39 ha which does not contain the signature of the user agency.
- 5. The DFO, Kurnool has uploaded S.I topo sheet map for re-diversion area of 5.74 ha however, which was not singed by him.
- 6. The DFO, Kurnool has uploaded the kml files of re-diversion area. But they are not accessible.

In view of the above, the CCF & FD, PT Circle, Srisailam is requested to instruct the DFO, Nandyal to rectify the above short-comings observed and process the re-diversion proposal duly obtaining the required information from the user agency immediately, for further processing of the proposal through CCF, Kurnool Circle, Kurnool.
