**विषय** **Diversion of 0.7882 ha of forest land in favour of HPPWD for the construction of link road from Mandhorghat to Golan Km. 0/0 to 7/810, within the jurisdiction of Shimla Forest Division, Distt. Shimla, Himachal Pradesh - reg.**

**सन्दर्भ:** **Online Proposal No. FP/HP/ROAD/121782/2021 received on 24.07.2023**

महोदय,

मुझे कहने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गई हैं। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि आगामी कार्यवाही की जा सके:-

1. In Part-1, A -3 (xvii), the name mentioned in the authorization letter does not match the details of the person making the application
2. The KML uploaded under column C of Part-I online required correction on the following points:-
  - i. From the KML uploaded it is observed the road is being already constructed and the site inspection report uploaded by the concerned DFO does not specify its comments regarding the violation. furthermore, As per information provided under column 5 of Part -II online, the area that falls under U-36 Madhorghat has been prescribed Plantation WC & U-35 Golan prescribed as Biosphere as per Working Plan. therefore documentary evidence of the existing path may be provided. As such clarification for the same is required to be submitted.
  - ii. The KML file of the project site uploaded doesn't have clear demarcation for forest/ non-forest areas. Hence, the KML file indicates Forest/ Non-forest areas along with broken and unbroken areas.
  - iii. As per the DSS analysis, the proposed DA is 0.7883 ha however, the calculated area is 0.48 ha. Therefore, State Govt. may review the difference in the proposed DA area and calculated area, and accordingly, fresh KML may be uploaded
3. A digital copy of the layout Plan in an appropriate scale which must include a legend and the proper dimensions of each component, such as Carriageway, Paved Shoulder, Earth Filling, Drain, and Protection Work, as well as area-wise calculations and Forest/Non-Forest area in different colors duly authenticated by the concerned DFO's needs, be uploaded
4. The Muck Management Plan uploaded needs to be duly authenticated by the concerned DFO

5. In Part II, KML file of the proposed CA site, CA scheme, DGPS map of CA site, CA site marked in Toposheet shall be uploaded to designated columns of Para-13
6. As per para 13(3)(c), of the Consolidated guidelines and clarifications issued under (Sanrakshan evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan evam Samvardhan) Rules, 2023, if the proposed CA land is Govt Wasteland falling under the category of protected forest and is neither demarcated on the ground nor transferred and mutated in the name of the Forest department in the revenue record has to be declared as PF under IFA 1927. The State Govt is requested to send clarifications in this regard for the CA land submitted in the instant proposa
