- (6) Any study carried out on Vultures of submergence area of Dodhan Dam Project.
- (7) Reasons recorded for not considering Buffer Zone as degraded forest area within PTR.
- (8) Actual surface area of submergence in the project as per digital terrain modelling.

In addition to above in Lower Orr area, following additional information was desired for evaluating the project on Decision Support System of MoEF&CC:

- (1) Shape file of command area.
- (2) Shape file of Submergence area.
- (3) Shape file of Karera's GIB Sanctuary
- (4) Shape file of Existing Canal System on Betwa River and its tributaries.

Committee observed the selection of statistical method to assess existing crop is inappropriate as Forest stands/vegetation were appearing more than what has been projected.

Therefore, in view of above information desired may kindly be furnished at an early date.
