Subject: Diversion of 1.4043 Ha in WLM Kinnerasani division for Conversion of existing electrical line by using ABC cable and extension of 3phase power supply to Venkatapuram ST Habitation in Allampally Mandal of Bhadradri Kothgudem District in Favour of SE, Operations, Bhadradri Kothagudem, TSNPDCL

Reference: The State Government vide letter Nos. 3705/For.I(1)/2022, dated 20.07.2022 and PCCF letter No FC4/FC26/3/2022 dated 17.12.2022 and online proposal No FP/TG/TRANS/155864/2022

Madam.

With reference to the above cited proposal, I am directed to inform that the proposal was examined and noticed that the following additional information / documents / clarification are required.

- i. As the forest area proposed for diversion is located within Kinnerasani WLS, the approval of competent authority under Wildlife Protection Act, 1972 may be obtained.
- ii. As per the provisions of FC Rules 2022, equivalent Non-Forest Land for Compensatory Afforestation is to be handed over to the SFD by the User Agency. Hence, the user agency may be directed to identify suitable equivalent Non Forest Land for CA purpose and suitable CA scheme, map, kml file, suitability certificate etc may be prepared by the SFD and submitted through online.
- iii. As per the Kml file, some part of the proposed area falls in agricultural land, hence the status of the area shall be furnished with supporting documents.
- iv. RoFR certificate from the competent authority is not submitted.
- v. DFO in his inspection report stated that the existing line is erected prior to 1980, however, supporting documents in this regard are not enclosed. Documentary proof of the existence of the present electrical line prior to 1980

as stated by the DFO in his report shall be provided.

vi. DFO in his site inspection report and Part-II stated that there are No rare/endangered/ unique species of flora and fauna in the area. The area being part of a Wildlife Sanctuary, status of existence of wildlife in the sanctuary may be indicated.
