Sub: Proposal for diversion of 79.5284 ha for laying of Natural Gas pipeline along with OFC from Dergaon-Dimapur in Doyang RF, Rengma RF, Nambor South RF and Diphu RF under Golaghat Div. in favour of Indradhanush Gas Grid Limited.

Sir,

With reference to the subject cited above, I am to inform that out of the total CA area i.e., 160.15 ha, 68.08 ha is very dense forest, 69.06 ha is moderately dense forest and 5.01 ha is non forest as per the DSS analysis report of FSI, Dehradun email dated 03.02.2022 (copy enclosed). Moreover, the proposed area is reported to be "INVIOLE" due to the presence of hydrological layer.

State Govt. is therefore requested to kindly furnish the following for further processing of this proposal:-

(i) State Govt to conduct a site inspection of the proposed CA area specifically, 68.08 ha very dense forest and 69.06 ha moderately dense forest as mentioned above by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density, inspecting officers name along with their photographs taken on the site along with GPS coordinates etc., or else, an alternate CA site is to be submitted along with SOI maps, site suitability certificate, GPS-coordinates, shape file etc.

(ii) Comment of the State Govt on the proposed area as it is "INVIOLE" due to the presence of hydrological layer as per the DSS report.
