I wish to inform that the Section 2 proposals under Forest Conservation Act, 1980 for providing BT to the road from Kuntam road to Thummiguda via Mettagudi of Saluru Range, Vizianagaram Division is inspected by the undersigned along with the Executive Engineer, Panchayat Raj, (PIU), Vizianagaram with the staff concerned on 06.02.2021.

During the field inspection it is found that there is discrepancy in the Forest area to be diverted for the said road from Kuntam road to Thummiguda via Mettagudi. The details area as follows.

The user agency in the D.G.P.S. map has shown the required Forest area is 1.10 hectors in 6 bits, but the details of length and width are not mentioned in any where, even in the Part-I proposal also (Please verify the area statement).

The S.I. map in 1:50,000 scale is to be enclosed with the road proposal, but the user agency has submitted in 1:15,000 scale map only. The DGPS map and S.I. map both are required to be furnished.
