
महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से सम्बन्धित संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.9505 हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव की इस कार्यालय में जांच की गई तथा निम्न बिन्दु आपकी जानकारी के लिए प्रेषित है:
- With reference to user agency's submission in its affidavit dated 17.2.2017, about pendency of an IA No. 29962/2013 in the Hon'ble Supreme Court, your attention is invited to para 2.1 (vi) of FCA guidelines which stated that " *the state government are advised not to consider/process cases, which are pending in various courts or sub-judice to avoid all sorts of administrative and legal complications*". Please comment.
  - In similar type of projects this office has received clarification from CEC dated 13<sup>th</sup> March, 2014 (copy enclosed) which is reproduced as under:  
" *The issues related to use of areas notified under section 4 & 5 of the PLPA for construction purposes is under consideration of the Hon'ble Supreme Court. The matter is expected to be listed for hearing in near future. Therefore. a decision on the such proposals may be taken in accordance with the directions of the Hon'ble Supreme Court.*"  
Please comment.
  - The proposal is not recommended by DCF Faridabad and CF, Gurgaon. Please clarify.

- x) Short narrative of the project in column A-1.(iii). Please provide brief note lines of the proposal having same sense.
- xi) Total period for which forest land required under column A1(x). Revised shown as 'NIL' is not valid.
