- 2. Certificate towards payment of NPV in respect of all other mines/ projects of the lessee situated in Keonjhar District and State of Odisha.
- 3. Certificate under FRA-2006 in respect of forest land.
- 4. Pending Court Matters, if any.

- 1. SOI Topo Sheet (1:50000) showing forest land required for diversion and boundary of adjoining forest land.
- 2. Present land use plan.
- 3. Proposed land use plan in respect of applied forest land.
- 4. DGPS map showing Patch wise DGPS coordinates of the forest land.
- 5. Details of approvals obtained/ sought for under the Act in respect of the project.
- 6. Details of land identified for CA with DGPS coordinates of the identified site.
- 7. Check list in the prescribed format along with specific information.
- 8. The compliance report along with documents/ undertaking to this office for processing of transfer proposal first. After received of above information, transfer proposal will be processed over 0.03 ha forest land.
- 9. Layout plan map of the proposed site.
- 10. Land schedule of CA duly signed by User Agency, Tahasildar & Range Officer.
- 11. Topo map, Shape / KML File of CA land.
- 12. Certificate as regards details of displacement.
- 13. All documents, certificate, undertaking should be submitted in original.
- 14. In the Form-A, Part- I the cost of the project has not mentioned. Please mention the same in Part- I, Form-A.

- 15. In the item No. 3, Form- A mentioned that the road and 33 KV transmission line passes through SZ over 0.03 ha is sabik kissam forest land. But, it is seen in the KML file enclosed in the DP that the proposed forest land applied for diversion is Revenue Forest land also mentioned the same on check list No.- 7. Please clarify the same.
- 16. Please provide the authenticated SZ map showing the proposed road and transmission line and enclosed in the DP.
