In the reference 3rd and 4th cited District Forest Officer, Villupuram Division recommendation along with Site inspection report in Form A Part II and Conservator of Forests, Villupuram Circle recommendation in Form A Part III of the proposal has been forwarded to the Nodal Officer.

In the Site inspection report of the District Forest Officer and recommendation of the Conservator of Forests it has been reported that there is one tree of Dalbergia sissoo at the south west boundary of the road which falls within the proposed diversion area. But in Form A Part II uploaded by the District Forest Officer, Villupuram under segment 4, two number of trees has been mentioned in girth class 61 to 90 cm and 91 to 120 cm. In this regard the Conservator of Forests is requested to upload the correct details.

In the reference 3rd cited, the District Forest Officer has furnished that Compensatory Afforestation details only for 2 years. As per the GOI guidelines F.No. 11-168/2009-FC(Pt) dated: 14.02.2012 the Compensatory Afforestation scheme with provision for maintenance of Afforestation for 7 - 10 years should be made. The Conservator of Forests is requested to upload the revised Compensatory Afforestation details for 7maintenance up to to 10 years.
