Proposal for diversion of 7.102 ha. of revenue forest land for diverting 220 KV Budhipadar-Sub: Basundhara transmission line from Location No.59 to Location No.75 from the premises of STPP, Darlipali, NTPC Ltd. in Sundargarh district, Odisha (Proposal No. FP/OR/TRANS/8680/2014)

I am directed to invite reference to your letter No. 2246 dt. 3.2.2017 in which above mentioned forest diversion proposal was submitted for consideration. On scrutiny of the forest diversion proposal, the following shortcomings are observed, which need to be complied with for further processing the proposal.

- (i) FRA compliance of Collector, Sundargarh pertaining to forest land proposed for diversion, has not been furnished.
- (ii) Letter of competent Revenue authority identifying/allotting non-forest land for CA has not been furnished.
- (iii) Plate No. 20(CA land shown in Nuadihi mouza map) has not been authenticated by Tehsildar, Lephripara and DFO, Sundargarh.
- Total non-forest land required for the project(with specification like Government, Private (iv) land) has not been indicated. Detailed land use plan of the project(indicating tower area, transmission line etc) for the total project area may be provided.
- (v) Total length of proposed transmission line passing through forest area and no. of towers to be erected in forest/non-forest area may be given.
- No. of trees barely necessary for felling in forest and non-forest area and remaining to be (vi) pruned, may be indicated.
- (vii) Height from the ground level and width of RoW of proposed transmission line may be indicated.
- (viii) Longitudinal and latitudinal extent of the proposed transmission line may be indicated.
- (ix) Copy of administrative approval of Energy Department for diversion/relocation of 220KV Budhipadar-Basundhara transmission line from Loc. 59 to Loc.75 may be provided.
- Total length of Budhipadar-Basundhara 220KV transmission line may be indicated. (x)
- Soft copy of DGPS map in CD form in triplicate may be provided. (xi)
