Please also find attached herewith routes map of proposed forest land diversion for your ready reference and same is as per Annexure-II.



In this fax message they have also clarified that when the proposal of diversion of protected forest along the highways is considered by the Government the land of this state highway are acquired by the state government under the provisions of the land acquisition act 1894
