You may kindly be aware that, the 132 kV D/C Biswanath Chariali to Itanagar Transmission Line has been awarded to NER II Transmission Ltd., by REC Transmission Project Co. Ltd. (**A wholly owned subsidiary of REC**). As line is passing through forest land and proposal for diversion of 48.147 ha of forest land had been submitted through online forest clearance portal on 06.03.18 and MoEF&CC, Regional office, Shillong accorded approval of for it.


Now, during execution of project a restriction encountered from Airports Authority of India for construction of 11 Nos. towers in the approved route due to height restriction for newly declared airport at Holongi in Arunachal Pradesh near Assam state boundary. Hence, a proposal for diversion of additional 16.853 ha Forest land submitted on MoEF&CC portal online to construct the portion of Transmission line under restriction of AAI.

The Nodal Officer, F.C. Act, Arunachal Pradesh has examined the proposal submitted online and found complete in all respect. Now the Nodal Officer has advised to submit the duly signed hard copy of the above proposal along with all necessary enclosures to the concerned Divisional Forest Officer and District Collector.

As per "Schedule Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006" compliance has to be ensured for diversion of Forest land for non-forest purposes and guidelines are circulated by MoEF, Govt. of India vide memo F.No.11-9/98-FC (Pt.), dated 5th Feb' 2013 & 15th Jan 2014. 
