Sub:	(R&B) Division ,Chittoor – Improvements to Rayalpeta- Madhavaram road (via) Penugolakala from Km 0/0 to 16/0 in Chittoor District- - Linear diversion of forest land of 3.34 Ha for improvements of the road from Km 9/9 to 13/8 in Keelapatla & Thumba North Reserve Forest of west division in Chittoor District - Requested - Reg.

I submit that the work "Improvements to Rayalpeta- Madhavaram road (via) Penugolakala from Km 0/0 to 16/0 in Chittoor District" was sanctioned under RIDF-XII for Rs 260.00 Lakhs and the same was entrusted to Sri N. Sreenath Reddy at 4.95% Excess vide CR agt No 44/2007-08. The work could not be carried out from Km 9/9 to 13/8 since the road is passing through the reserve forest.

Improvements of this road from Km 9/9 to 13/8 (3.90 Kms) facilities more than 30.00 Kms reduced for the people travelling from Peddapanjani(M) to Thavanampalli (M).would further improve connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved. The present is earthen road passing through Reserve forest and to make the road bituminous surface is for which linear diversion of 3.34 Ha of forest land is required.
