With reference to the above, 400KV DC line with Quad moose ACSR for a route length of 179.85km from UPCL Nandikur to Shantigrama was charged on 25.08.2012. This line is one of the most significant transmission line catering energy demands of the state of Karnataka. The entire project for the construction of 400KV DC line covered an area of 172.53ha of forest land. To get clearance for the forest land, a diversion proposal was submitted and subsequently forest land of 172.53 ha required for the project was diverted in the year 2012 by Government of India vide order F.No.8-29/2010-FC dated: 17.02.2011 & 17.01.2012 and Government of Karnataka by its G.O. No. FEE.20.FGL/2010:BANGALORE dated: 01.02.2012.

However, an area of 2.5766 Ha of forest land was left out while marking the area of forest land mistaking it for a government land. In consequence, an online proposal for diversion was submitted for the additional 2.5766 Ha of forest land seeking ex-post facto approval under Forest (Conservation) Act vide proposal No. FP/KA/TRANS/36286/2018 in favour of the Executive Engineer (Ele.), 400KV Transmission works Division, KPTCL, Udupi.

The submitted online proposal has been examined by the Nodal Officer, FC, Government of Karnataka and has been found to be complete in all respect and hence intimated vide ref (2) to submit duly signed hard copy of the proposal along with all necessary enclosures to the office of the concerned Divisional Forest Officer and the District Collector and upload copy of the acknowledgement as per given format, obtained from each of the above authorities.
