Sub: TSFD F(C) Act, 1980 diversion of 4.306 Ha of Forest Land (1.272 Ha in Kamareddy + 2.345 Ha in Nizamabad Divisions) for improvement of Banswada Uppalvai road from Km 0/0 to 40/3 in Nizamabad District in favour of EE, Public Work (R&B) Dept, Bodhan Reg.

It is informed that the Executive Engineer, R&B Dept, Bodhan vide referenc 2nd cited has frunished revised proposal for diversion of 4.306 Ha of Forest Land for improvement of Banswada Uppalvai road from Km 0/0 to 40/3 in Nizamabad District, falling in the jurisdiction of the following divisions.

1- Kamareddy - 1.272 Ha
2- Nizamabad - 2.345 Ha

Six sets of proposal are sent herewith to Kamareddy & Nizamabad Divisions for processing the same under Forest Conservation Act, 1980 and as per the guidelines issued there under. The proposal has been uploaded in the Ministry's website (www.forestclearance.nic.in) by the User Agency and a unique File Number: FP/TG/ROAD/16293/2015 has been generated by the Ministry's website for this file.

They are requested to critically examine the requirement of forest land for the above project and satisfy himself that the requirement of land for the project is unavoidable. They are also requested to examine the proposal in totality and furnish all the necessary details in the Part-II. In this connection, he is also requested to carryout site inspection and enclose the field inspection report with photographs of the spots visited included in the FIN; take up enumeration of trees to be felled, if any, in the proposed area for diversion and submit Abstract of enumeration species and girth class wise in the following Proforma:

They are requested to specifically mention about the source and / or method for indicating the density of vegetation, vulnerability to soil erosion, the impact of the project on adjoining flora and fauna and also suggest mitigative measures for the

protection of flora and fauna and record specific recommendation or otherwise for the project.

The Divisional Forest Officers, are further requested to specifically mention if the proposed area is falling in National Park / Wild Life Sanctuary or the Eco-sensitive zone. If so, he is requested to direct the User Agency to submit proposals in the Wildlife formats to the Prl. CCF. If not, the distance from the nearest WLS / NP shall be clearly mentioned.

The DGPS authenticated maps are enclosed herewith. The Divisional Forest Officers are requested to verify the absolute locations of BPs in the field & also to verify entry & exit points with Reserve Forest and furnish feedback and if any difference is found, same maybe modified in map & accordingly revised Part-I may be obtained.

They are also requested to examine the proposal in the light of guidelines issued regarding RoFR Act vide MoEFLr. No. 11-9/1998-FC (pt) Dt. 03.08.2009, 05.02.2013 & 05.07.2013 and submit a certificate in the prescribed format Annexure-I (Form-I) duly certified by the District Collector for evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (RoFR) Act, 2006 duly annexed to each set of the proposal.

They are requested to submit the proposals in a complete shape duly filling information in Part-II with specific recommendation, within stipulated time to the Chief Conservator of Forests/ Conservator of Forests, Nizamabad; along with information in check slip, for further processing/ consideration of the proposal.

They are specifically directed to upload information pertaining to Part-II of the proposal in the Ministry's website (www.forestclearance.nic.in) and furnish attested copy of the acknowledgment slip with the proposal.

Early and time bound action is requested.
