The SE, PR Circle, Karimnagar in the ref 5<sup>th</sup> cited has furnished proposal under Forest (Conservation) Act, 1980 for diversion of 4.439 Ha of forest land in Karimnagar (East) Division formation of Reddipally to Kanakanoor Road in Karimnagar District in favour of EE, PR Division, Peddapally. The proposal has been uploaded in the Ministry's website (<a href="https://www.forestclerance.nic.in">www.forestclerance.nic.in</a>) by the User Agency and a unique File Number: FP/TG/Road/16776/2015 has been generated by the Ministry's website for this file.

Six (6) sets of proposals are alongwith this letter to the Divisional Forest Officer, Karimnagar (East) for processing the same under Forest Conservation Act, 1980 and guidelines/ rules issued there under.

The Divisional Forest Officer, Karimnagar (East) is directed to critically examine the requirement of forest land for the above project and satisfy himself that the requirement of land for the project is unavoidable. It is also requested to examine the proposal in totality and furnish all the necessary details in the Part-II. In this connection, he is also requested to carryout site inspection and enclose the field inspection report with photographs of the spots visited included in the FIN; take up enumeration of trees to be felled, if any, in the proposed area for diversion and submit Abstract of enumeration species and girth class wise in the following Proforma:

He is also requested to specifically mention about the source and / or method for indicating the density of vegetation, vulnerability to soil erosion, the impact of the project on adjoining flora and fauna and also suggest mitigative measures for the protection of flora and fauna and record specific recommendation or otherwise for the project.

He is also requested to examine the proposal in the light of guidelines issued regarding RoFR Act vide MoEF Lr.No.11-9/1998-FC (pt) Dt.05.07.2013 and submit a certificate in the prescribed format Annexure-I (Form-I) duly certified by the District Collector for evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (RoFR) Act, 2006 alongwith all relevant documents as mentioned in MoEF, GoI Lr. dt.03.07.2009 duly annexed to each set of the proposal.

Equivalent non-forest land for Compensatory Afforestation is not required for the subject project as the proposed area for diversion is less than 5.00 Ha and is falling in notified LWE Karimnagar District. However, if the number of

trees to be felled in the forest area proposed for diversion is more than 50 trees Per HA, then the proposal doesn't come under the General Approval and the User Agency is required to identify equivalent non-forest land for CA adjoining the forest lands. Accordingly, CA to be prepared as per the specification issued by MoEF, GoI from time to time with 7 to 10 years maintenance.

The Divisional Forest Officer, Karimnagar (East) is also requested to submit the proposals in a complete shape duly filling information in Part-II with specific recommendation, alongwith detailed information as called for in the ref  $4^{\rm th}$  cited within stipulated time to the Conservator of Forests, Warangal; along with information in check slip, for further processing/ consideration of the proposal.

He is specifically directed to upload information pertaining to Part-II of the proposal in the Ministry's website (<a href="www.forestclearance.nic.in">www.forestclearance.nic.in</a>) and furnish attested copy of the acknowledgment slip with the proposal.

Early and time bound action is requested.
