The aforesaid proposal is now forwarded herewith for completion of procedural formalities and simultaneous processing in the web site portal as per the Guidelines received from the Ministry of Environment, Forests & Climate Change, Govt. of India. Please ensure that all the requisite documents are made available with the proposal and submitted in time bound manner:

- 1 The forest land involved under the project shall be verified and authenticated in consultation with the User Agency.
- 2 All the Maps and Plan shall be authenticated by all concerned.


- 3 Original or scanned copy of toposheet map showing the location of project site and Compensatory Afforestation site may be made available with the proposal.
- 4 The distance of the project site from the nearest boundary of the WL Sanctuary may also be obtained from the DFO (WL) North.
- 5 A certificate in respect of degraded forest land identified for Compensatory Afforestation may also be furnished along with the polygon.
- 6 The User agency may be advised to obtain the Certificate from the District Collector, in Form I & II, in connection with the settlement of rights over the proposed forest land under Scheduled Tribes and Traditional Forest Dwellers (Recognition of Rights) Act, 2006, if required.
- 7 A Joint Certificate of non-availability of non-forest land for compensatory afforestation may be obtained from the District Collector and Divisional Forest Officer of the concerned Division also as required under the Rules/Guidelines.
- 8 The User agency may be advised to submit the Geo referenced map of the forest land proposed for diversion and CA site also. They may get it prepared in the WP GIS Lab on payment charges in this respect.
- 9 The user agency may be directed to submit the identified muck disposal site and muck disposal management plan duly approved/agreed by the State Govt. for the aforesaid project proposal.
- 10 Forest clearance Online Part II printed copy may also be furnished with the proposal.

After completion of procedural formalities, the proposal may be forwarded to the CF (T) through online as well as offline mode also for further action to be taken accordingly.
