Road and Building Department, Government of Gujarat has decided to take up the development of Four Laning of Gandhinagar K-7- Randheja- Balva -Mansa Road, Km.(7/500 to 15/500), where the intensity of traffic is very high .

The proposed project of widening and strengthening of Gandhinagar K-7- Randheja- Balva -Mansa Road, Km. (5/200 to 15/500) is essentially a highway widening project. Both side widening of existing road within existing right of way (ROW) of R&B Department are notified Protected forest form existing Km 5/200 to 15/500 section of Road name Gandhinagar K-7- Randheja- Balva -Mansa Road, Km. (7/500 to 15/500). By Gujarat Government . Protectd Forest area diversion is proposed to met the minimum requirement of geometric design parameters and safety aspects of highway.

The project road passes through Gandhinagr and Kalol Taluka of Gandhinagar district. Widening Is proposed within existing Row Since road side plantation within existing Row will attract provision of forest Conservation Act,1980. Therefore we need diversion protected forst area for the Upgrade to widening and strengthening of the project road Further, Ist Is to Inform thet. There is no reserved forest (RF) land proposed for diversion .

The breakup of protected forest area proposed for diversion is given below table.


