Dear Sir,

Please find enclosed herewith a proposal along with Annexures in four copies for granting of No Objection Certificate for laying of 300mmØ HDPE Effluent Pipeline in Protected Forest land as mentioned above.

It may kindly be noted that Effluent Pipeline will be laid in Bharuch District as under:


- 1) Across – 40.50 mt on SH-6 Asphalt Road (Bharuch - Dahej)

The pipeline will be laid by excavation of a narrow strip of trench of size 90.00 cm width and by horizontal directional drilling (HDD) for pushing the casing pipe wherever required. The same strips of the trench will be reinstated to its original condition and the land area in question will not be required to be handed over to the Navin Fluorine Advanced Sciences limited for its exclusive use. The Applicant will not have any right other than that of the user. It is also intimated that no structure will be erected on the pipeline route. The proposed Effluent pipeline will be laid underground at a depth of 1.5 mtr and its width is 0.9 mtr (less than one meter) and not tree cutting is required. You are requested to grant Protected Forest permission under general approval as per new Guidelines of Government of India, Ministry of Environment Forests & Climate Change, (Forest Conservation Division), New Delhi dated 27.07.2020

The pipeline route proposed is most economical and use of bare-minimum forest land to lay on SH-6 Asphalt Road (Dahej-Bharuch) as stated herein above. It is not possible to lay from any other alternate route except to use the proposed route of pipeline. **Executive Engineer, R&B Division, Bharuch** have been requested to allow to lay pipeline as stated herein above and permission is likely to be received shortly.

It is not possible to get land for laying the pipeline other than the road being used by the Forest Department.

Considering the above, you are requested to grant the permission for the above works at the earliest and oblige.
