GSPC and BPCL have agreed to synergize their resources and strengths to form a Joint Venture Co. for setting up the infrastructure for distribution and marketing of Natural Gas, Compressed Natural Gas (CNG) and Piped Natural Gas (PNG) in Gandhinagar, Mehsana and Sabarkantha Districts of Gujarat State.
