

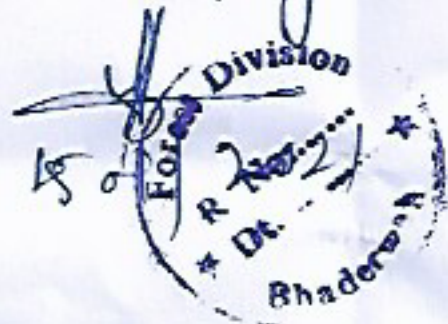


Sir,
