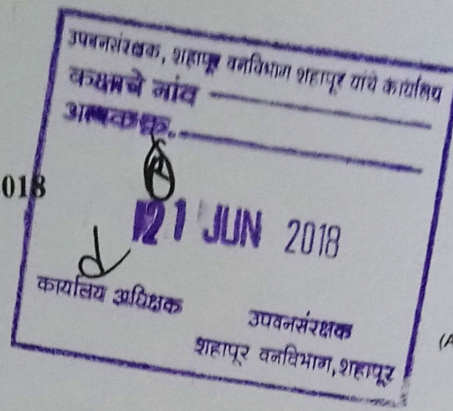

**Respected Sir / Madam,**

The Government of Maharashtra has announced Six-lane Nagpur-Mumbai Super Communication Expressway (NMSCEW) project between Nagpur and Mumbai, the implementing agency for which is Maharashtra State Road Development Corporation (MSRDC). The entire length of the proposed expressway is about 701 km and is divided into five packages of which Package -V is of 78 km from village Taranganpada, Igatpuri Taluka, Nashik District to village Amane, Bhiwandi Taluka in Thane District.

A portion of Expressway passes through forest area admeasuring 383.8535 Ha, therefore it involves diversion of this forest land for non-forestry purpose under Forest (Conservation) Act, 1980 to be granted by MoEFCC, Government of India, New Delhi. In compliance to the provisions of the above Act, an application seeking diversion of 383.8535 Ha in "Part I of Form A" as prescribed under procedure was uploaded on MoEF portal bearing Proposal No. FP/MH/ROAD/34047/2018. In continuation to the same we are hereby submitting Hard copies of the proposal for your further necessary actions.

You are kindly requested to process the proposal with due precedence to the application considering that this project is a top priority venture of the Maharashtra Government.
