
Vide reference 4<sup>th</sup> cited, the District Collector, Siddipet issued Non-Encumbrance Certificate and under taking letter for non-forest land for CA land in Sy no 876 extent 2.1815 Ha (5.29 Acre) Koheda (V), Koheda (M) Husnabad Division, also this office submitted the CA land particulars of 2.1815Ha(5.29Acre) with RAW data for verification and authentication of land in Siddipet District.(CA land for both Siddipet and Medchal Districts).

Vide reference 5<sup>th</sup> and 6<sup>th</sup> cited above, the District Collectors, Siddipet and Medchal Districts, have issued ROFR Certificates for the said land 1.6967 Ha in Siddipet district and 0.4848 Ha in Medchal Malkajgiri District with necessary Encumbrance certificate and undertaking letter for non-forest land diversion for an extent of 0.4848 Ha and the same is here with submitted.

In this regard, I request the Principle Chief Conservator of Forests (HOFF) to take further necessary action.
