Subject: Diversion of 3.871 hectare of forest land in favour of Executive Engineer, TS Division, HVPNL, Rewari for erection of 132kV D/C transmission line from 220kV S/Stn. HSIIDC Bawal to 132kV S/Stn. HSIIDC Bawal, crossing through various forest strips, under forest division & Distt. Rewari Haryana.

It is intimated that subject mentioned case was submitted on line vide proposal no. FP/HR/TRANS/6597/2014 on 05.11.2014. Hard copies of above proposal were submitted to your office and office of Deputy Commissioner Rewari on 12.11.2014. Vide your office reference no. 2211 dated 17.12.2014 it was conveyed to this office that 3.871 Ha (i.e. 9.567 Acre) land in lieu of land proposed to be used for erection of above mentioned transmission line may be provided to forest department for consideration of proposal. In this connection it is intimated that route of this transmission line is in area of Indl. Growth Centre of HSIIDC Bawal. The land now owned by forest deptt. was also handed over by HSIIDC. This work of erection of transmission line is also being carried out by HVPNL as deposit work of HSIIDC. So as per your requirement, HSIIDC has identified 3.871 Ha land at Sec-9 IGC HSIIDC Bawal. After inspection of this land proposed to be transferred to forest deptt. in lieu of forest land to be used by HVPNL for erection of transmission line, your office had issued consent for transfer of land vide your office memo. no. 188 dated 08.05.2015. As conveyed to you by AGM (IA) HSIIDC Bawal vide his office memo. no. HSIIDC/IMT/15/1025 dated 25.06.2015 (copy attached for ready reference), HSIIDC has accorded in principle approval for exchange of 3.871 Ha land of forest deptt. situated in Sec-2 & 3 with HSIIDC land in Sec-9. So you are requested to accord approval for commencement of work of erection of subject mentioned transmission line in the area presently owned by forest deptt. It is pertinent to mention here that this transmission line is vital electrical link for providing relief to the highly overloaded power system in Bawal area. So it is requested that matter may kindly be considered on priority.
