Sub: Permission to lay Optical Fiber Cable along the road within the existing Row under **Gudur WLM, Mahabubabad, Warangal R, Yellandu Divisions** Division for the total extent of 1.997 Ha in Forest land in State Of Telangana by Open Trench method - Reg.

Further, the Width of Trench is 400 mm X depth 1200 mm. The alignment of Trench will be done in such a way that no trees will be Cut/Damaged. The OFC would be laid in the existing RoW of the Road authority concerned as per the MoEF circular cited above under reference 2.

We have uploaded the proposal in the MoEF portal under **Gudur WLM, Mahabubabad, Warangal R, Yellandu Divisions** Division for the total extent of 1.997 Ha (Length 49931.51 M X Width 0.40 M) as authenticated under reference 3 cited above, the acknowledgement of which is attached herewith under reference 1 cited above.
