Sub: Construction of 6 Lane access controlled Highway from DND Maharani Bagh to Junction with Jaitpur-Pushta Road Section of NH-148 NA (Design Ch. 0+000 to 9+000) in the NCR of Delhi (Pkg-I) under Bharatmala Pariyojana(Lot-4/Package-1)-Reg.submission of hard copies of Forest Proposal under Forest (Conservation) Act, 1980 for Diversion of 0.35 Ha deemed forest land under South Forest Division, Delhi for non-forest purpose.

Sir,

It is to inform you that National Highways Authority of India (NHAI), under Ministry of Road Transport & Highways, Government of India, has proposed the "Construction of 6 Lane access controlled Highway from DND Maharani Bagh to Junction with Jaitpur-Pushta Road Section of NH-148NA (Design Ch. 0+000 to 9+000) in the NCR of Delhi (PKG-I) under Bharatmala Pariyojana (Lot-4/Package-1)".

- 2. In pursuance of the above, Corridor Management Unit Mathura, NHAI at Faridabad is taking up above mentioned project in the state of Delhi having a total length of 9.0 Km and Proposed Right of Way (PROW) is varying in between 11.5 m to 40 m. Sufficient care has been taken during the design stage to avoid acquisition of forest land located along the project road. The proposed project falls in deemed forest land and diversion of deemed forest land is unavoidable and barest minimum i.e. 0.35 Ha.
- 3. The forest land as identified is included in this proposal for your kind consideration and recommendations for grant for the diversion of forest land for non-forest purpose. It is also stated that NHAI is willing to pay compensation for Compensatory Afforestation (CA) and Net Present Value (NPV) etc. as per the Government regulations.
- 4. This is a time bound project and has a potential to contribute in the economic well being of local people of the adjoining area. Therefore, it is requested to consider the proposal and recommend granting the permission for the diversion of forest land.
