It is to inform that, the proposal for diversion of forest land to an extent of 0.97 Ha in Compt.471 of Ghanpur RF of Wanaparthi forest division under Wanaparthi District, for the formation of Ghanpur branch canal was submitted to the Principal Chief Conservator of Forests &, Head of Forest Force vide reference 1st cited.

The Principal Chief Conservator of Forests &, Head of Forest Force vide reference 2nd cited, has communicated the extent of alignment passing through notified forest area as 0.8755Ha. The forest proposals for processing of DGPS surveyed data for an extent of 0.8755Ha was submitted to the Principal Chief Conservator of Forests &, Head of Forest Force vide reference 3rd cited.

The Principal Chief Conservator of Forests &, Head of Forest Force vide reference 4th cited has forwarded the proposals to the District forest officer for examining the forest land requirement for the above proposal.



In this connection, the DFO, Wanaparthy along with R.D.O., Wanaparthy inspected the site and verified the coordinates of proposed forest land and measured the proposed area as per coordinates. Due to slight variation on the ground, the forest land covered under the Ghanpur branch canal in Ghanpur RF of Wanaparthy is worked out to **0.97ha** instead of **0.875ha**. The DFO, Wanaparthy orally instructed to send the proposal for **0.97ha** instead of **0.875ha**.

The area is surveyed with ETS/DGPS survey and the revised extent of forest land is worked out to **0.97Ha**. The particulars are enclosed in the format as desired by the Principal Chief Conservator of Forest of Telangana State, under section 2 of FCA Act 1980.

In this regard, it is requested to accord necessary clearance for the diversion of the required forest land so as to execute the canal works.
