Sub.: Ranasan – Harsol Looping Connectivity: Diversion of 1.050 Hect. of Protected Forest land i.e. Road side strip plantation declared as protected forest for laying of 8"dia Steel Pipe for supply natural gas to Ranasan and Harsol village in Taluka Talod, District Sabarkantha – Pipeline laying parallel and across to various State Highways along the pipeline route – **Request to Grant Permission**

Dear Sir,

Sabarmati Gas Ltd, is a Joint Venture Company of Gujarat State Petroleum Corporation Ltd. (GSPC) and Bharat Petroleum Corporation Ltd. (BPCL). GSPC and BPCL have agreed to synergize their resources and strengths to form a Joint Venture Co. for setting up the infrastructure for distribution and marketing of Natural Gas, Compressed Natural Gas (CNG) and Piped Natural Gas (PNG) in Gandhinagar, Mehsana and Sabarkantha Districts of Gujarat State.

As a part of the project, we are planning to lay 8" Steel Pipeline to supply natural gas to Ranasan – Harsol Village Taluka Talod District Sabarkantha from our proposed Modasa Spurline. The total length of proposed pipeline is 17/585 Km. The proposed pipeline will be laid in the space available alongside the road. The Company shall follow all the best standards of safety and inspection practices as is prevalent in the Gas Distribution Industry. The proposed pipeline shall be laid in the space available along side of the existing ROW of State Highway at a depth of 1.2 meter below the lowest ground level and width of trench will be 0.6 meter.

The details of pipeline laying parallel and across to various SH which has been declared as Protected Forest area furnished in **Annexure-A**.

For laying purpose 0.6 mt. width of forest strip is proposed for the pipeline parallel and across to various State Highways in Sabarkantha District, with this provision of 0.6 mtr. Width and 17505 mtr. length is required for parallel and across to State Highways. The total forest area **1.050 Hect.** is required for above said project in protected forest for pipeline laying parallel and across to various State Highways at various location in Sabarkantha District.

We would like to inform that the location of pipeline crossing has been selected in such a way that minimum tree cutting is involved. For other areas, which are not been declared as protected forests, a separate proposal is being submitted for seeking permission for cutting of trees if any, obstructing the pipeline route.



The forest lands as identified by us are included in the application. However, if any crossing area is left out, the same may please be included. The route map of the above said project is enclosed herewith for your reference. It will be worthy to state here that the pipeline will be laid 1.2 mtr. below ground level, the upper lands will be open for normal movement.

Necessary application, along with Annexure in Four sets is submitted herewith for perusal and recommendation to grant permission to lay the pipeline. We are willing to pay compensation for compensatory afforestation and also Net Present Value (NPV), etc as per rules and has given undertaking as required.

Therefore most expeditious actions are requested to recommend and to grant the permission for right of way and also permission to remove the trees obstructing the route, if any.
