4. District Welfare Officer, Jajpur again vide his letter no. 2372, dated 26.12.2015 directed Block Development Officer, Sukinda to convene Palli Sabha. Copy of the letter is enclosed as

5. Tahsildar, Sukinda on 28.12.2015 has also requested Block Development Officer, Sukinda vide his letter no. 3331 to convene Palli Sabha at the earliest. Copy of the above letter is enclosed as **Annexure-V** for your ready reference.

Sub: Issue of Certificate under ST & OFD (FRA) Act, 2006 for grant of Forest Clearance over 330.972 ha. of forest land to be diverted in respect of Sukinda Chromite Mine lease over 406 ha in Jajpur District.

Dear Sir,

We had applied for renewal of the Forest Clearance for 73.697 ha of forest land already diverted in respect of Sukinda Chromite Mine over 406 ha. You have issued the certificate under Forest Right Act, 2006 and the same was sent to the Divisional Forest Officer, Cuttack Forest Division vide Memo No 2200 dated 6.12.2012 (copy enclosed). Now we have been asked to submit Forest Diversion Proposal over 330.972 ha of forest land as on 25.10.1980. To comply with the provisions of the Schedule Tribes & Other Traditional Dwellers (Recognition of Forest Rights) Act, 2006, we are required to obtain a certificate for the above purpose from your good office.

The area of 330.972 ha of forestland comprises of only Government land and there is no privately owned land or encroachment. As such there has been no requirement of any rehabilitation and resettlement of any dwellers in the past and nor shall it be required in the future. The further details of the above mentioned area are enclosed as Annexure – I.

We therefore request you to kindly expedite the matter for issuance of the said certificates and forward the same to the Divisional Forest Officer, Cuttack Forest Division, Cuttack, for incorporation in our Forest Diversion Proposal for renewal of the Forest Clearance, which had been earlier granted.

Complete process for identification and settlement of rights under FRA, 2006 a) . has been carried out for the entire forest area proposed for diversion.

Pallisabha Resolution be recorded in local language (Oriya) duly signed by b) Sarpanch and member present.

Letter of willingness be obtained for proposed diversion with the fact that they have understood the purpose and details of proposed diversion and its C) implication and compensatory measures.

It is to be ensured that there is 50% quorum in the meeting. d)

Application of individual/community claims may be collected if any.

e) . It is to be ensured that FRC members along with the representatives of User f) Agencies are present in Pallisabha.

Video recording along with still photographs of Gram Sava may be ensured. g)

Money receipt supporting to payment of charges to the drummer may be h) kept.

Wide publication of Pallisabha notice to all concerned and at public places like i) School, Hat, Market and Panchayat Office.

This may be treated as MOST URGENT.
