It is informed that, the Executive Engineer, Panchayat Raj(PIU) Division, Paderu in the reference 3rd cited has submitted (7) sets of hard copies of proposal in connection with diversion of 2.65 ha. of forest land in Compartment no.860 of Sankaram RL and Compartment no.861,862 & 808 of madugula Beat, Visakhapatnam Division for formation of road from Paderu Waddadi R&B road to Konam via Poolabanda (PV R&B road at 12 mile to Devapuram) in f/o EE PR (PIU) Division, Paderu. Six(6) sets of the said proposal are sent alongwith this letter to the Divisional Forest Officer, Visakhapatnam Division for processing the same under Forest (Conservation) Act, 1980 and the guidelines issued thereunder.

The Divisional Forest Officer, Visakhapatnam Division is requested to critically examine the requirement of forest land for the above project and satisfy himself that the requirement of forest land for the project is unavoidable. He is requested to examine the proposal in totality and furnish all the necessary details

in the Part-II. He is also requested to carryout site inspection and enclose the field inspection report with photographs of the spots visited and same included in the FIN. Further, he is requested to carry out the enumeration of trees to be felled, if any, and the value of the trees to be felled in the proposed area for diversion and submit Abstract of such enumeration, species and girth class wise in the following Proforma:

He is requested to specifically mention about the source and method for indicating the density of vegetation, vulnerability to soil erosion, the impact of the project on the adjoining flora and fauna and also suggest mitigative measures for the protection of flora and fauna and record specific recommendation or otherwise for the project and submit in five (5) sets through the Conservator of Forests, Visakhapatnam within the stipulated time.

The Divisional Forest Officer, Visakhapatnam Division is further requested to specifically mention, if the proposed area is falling in National Park / Wild Life Sanctuary or within the Eco-sensitive zone or wildlife corridors and also mention the exact distance from the nearest WLS / NP duly enclosing the location map.

He is also requested to examine the proposal in the light of comprehensive guidelines issued regarding RoFR Act in Annexure –II of GoI F.no.5-2/2017-FC, Dt. 28.03.2019(copy enclosed) and submit a certificate in Form-I prescribed for linear projects other than Plantations duly certified by the District Collector for evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (RoFR) Act, 2006 duly annexed to each set of the proposal.

He is requested to submit the proposal in complete shape duly filling information in Part-II and with specific recommendation within the stipulated time through the Conservator of Forests, Visakhapatnam alongwith information in check slip, for further consideration of the proposal.

He is specifically directed to upload information pertaining to Part-II of the proposal in the Ministry's web portal (www.parivesh.nic.in) and furnish attested
