Subject: Proposal for diversion of forest land for construction of Malhar to Marhoon road, Package No. JK07-136, Phase-X, Stage-I, Length-18.433 Kms, Block Lohai Malhar, District Kathua.

Sir,

In reference to the above cited subject and in response to your above quoted letter wherein reluctance has been shown for allowing construction of road alignment beyond RD 12/975 due to irreparable loss of Pristine Deodar Forest (354 No. Trees), fragmentation of wildlife habitat, Disturbance to hydrology of the area, damage to main water source to habitation below and Fragile Soil Profile, it is submitted that this department also is of the same view and accordingly field staff has been directed to explore alternative and viable alignment beyond RD/975 which will take considerable time. Regarding construction of road upto RD 12/975 i.e. from Village Malhar to Chew via Malad for which the forest department has shown its willingness to allow construction of road, it is submitted that proposal already uploaded on PARIVESH Portal may be curtailed and processed upto RD 12/975 as Part-I and forest clearance from Village Chew to Marhoon for a length of 5.45 Km as Part-II shall be sought after realigning this stretch of road taking into consideration points raised by Forest Department.
