Sub: Diversion of 139.560 ha of forest land for construction of doubling Railway project from Jaroli to Parjanpur in Jakhapura-Bansapani Broad Gauge Railway line by East Coast Railway:- **regarding joint verification of the proposed sites at village-Nayagarh under Jhumpura Tahasil.**

Sir,

During site inspection by the undersigned on the aforementioned project on dated 08.03.2019, the following discrepancies are noticed which need to be clarified.

1. Pillar No.842, 843 & 845 has been posted outside the RoW which needs to be corrected in the field.
2. Pillar No.785 & 787 is missing which needs to be posted in correct place.
3. Since the forest diversion proposal submitted by M/s Bhushan for Railway Siding and Forest Diversion proposal submitted by the Railway authority are in active consideration at the division office and area in question is side by side. It is observed in the field that there is some discrepancy with respect to forest land boundary demarcation by both the agencies. Therefore it is felt necessary to conduct joint verification in the field and sort out the matter at an early date.
4. In view of the above, the undersigned is fixed a date on 15.03.2019 for joint verification of the overlapping plots with M/s Bhushan Steel Ltd. & Railway Authority in presence of Range Officer, Champua. Hence, it is requested to attend the scheduled date with relevant documents.
