

Sir,

Please refer to the State Government's letter 6353/FR.10/2020-2 dated 17.10,2020 and online application No. FP/TN/ROAD/41255/2019 and it is to inform that the subject proposal was considered by the REC in its 43<sup>rd</sup> meeting held on 27.11.2020 and after due deliberation the committee decided to defer the proposal and decided to seek the following documents / clarification from the State Government;

- a. Clarification on acquiring the non forest area prior consideration of the proposal and approval from competent authority and also further clarification required for considering forest clearance for 3<sup>rd</sup> reach alone when UA applied for 4.295 ha in 3 stretches.
- The State Government has to provide details of clearance i.e. copies of the Stage I & II approval for 0.7944 ha if any;
- c. Legal status of the existing road needs to be provided and whether existing road (width of 7 mtr) also included in the present proposal needs to be explained;
- d. As per the Site Inspection Report of APCCF Madurai Circle, considering the wild animal movements in the road appropriate mitigation plan needs to be submitted.



In view of the above, I am directed to request to furnish the information as mentioned above to this office at the earliest for further consideration of the proposal.
