Please refer to online proposal No FP/SK/ROAD/121301/2021 submitted in IRO, Kolkata dated 09.07.2021 on the subject mentioned above, seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The proposal forwarded by the State Government has been examined in this office in accordance to Forest (Conservation) Act, 1980, and rules/guidelines framed there under.

On perusal of the proposal, it has been observed that the project proponent indicated the employment details in Part-I under the head Employment (likely to be generated) Skilled- 8569 Man-days and Unskilled-18720 Man-days. Later on, it was corrected in PART- I at PARIVESH as Permanent/Regular Employment – 8520 and Temporary Employment- 18720.

In view of the above it is requested to provide the following information for further consideration of the proposal: -


1. As per the submitted FORM A (Part-I), employment has been categorized in Skilled labour and Unskilled labour and hence both the categories come under temporary employment. Thereafter it has been corrected as



permanent and temporary. This needs to be clarified and the details of employment needs to be provided in appropriate category in PART-I.

The above-mentioned additional information needs to be uploaded/rectified in PARIVESH portal accordingly.


