Sub: Diversion of 10.0956 hectare of forest land in Sy No.1/A and 1/D of Uchangidurga Village, Arasikere Hobli, Harapanahalli Taluk, Davanagere District for establishing M-Sand Quarry and its Approach Road in favour of M/s ANNAPOORNA STONE CRUSHER (*a Partnership Firm of Sri T. Basappa s/o T. Sidappa, Smt M.C. Poornima w/o Sri T.Basappa and Sri B.Nikhil, s/o Sri T.Basappa, #1120, 3rd Cross, Taralabalu Extension, Davanagere*), Sy No.1D, Uchangidurga Village, Harapanahalli Taluk, Davanagere District

Ref: Online submission of PART-III by you on 05-02-2020 [letter No. M1:MNG:QRY-Road:CR:7/2019-20 dated 05-02-2020]

With reference to the above subject, the proposal (PART-I, II & III) seeking Stage-I clearance under Forest (Conservation) Act, 1980 received from you vide above letter has been examined. However, it is noticed that the proposal is **INCOMPLETE** in following respect.

1. The Compensatory Afforestation scheme, which is an integral part of all Stage-I proposals has not been uploaded by the Deputy Conservator of Forests, Davanagere Division in Item 13 of PART-II of the proposal. The hard copy of the same has also not been submitted.
2. There is lack of clarity on the exact legal status of the land in Sy No. 1/A and 1/D of Uchangidurga village, that is proposed for diversion under the Forest (Conservation) Act, 1980 and are mentioned as RF area and Section-4 area respectively.

You are therefore, directed to:

1. Obtain CA scheme prepared in accordance with the present CA rates and Para 2.8 (ii) of the FC Guidelines from Deputy Conservator of Forests, Ballari Division and ensure that the CA scheme is uploaded in Item 13 of PART-II of the proposal. The same should also be submitted in minimum three original ink signed sets to this office.
2. Clarify on exact legal status of the land concerned along with copy of relevant Government Notifications and / or other records.

You are required to forward the online link to the Deputy Conservator of Forests, Davanagere Division for enabling uploading of the CA scheme and above clarification in PART-II on FC web portal.
