Sub: - Regarding proposal for diversion of forest land for Jagdishpur-Haldia-Bokaro-dhamra pipeline, for laying Natural Gas pipe line from Jagdishpur to Haldia via Chatra District in the Sate of Jharkhand.

## **Respected Sir**,

A proposal (Hard Copy) for diversion of 10.16 Ha. Of forest land has been submitted in 08 copies attached with your above referred letter. After perusal of proposal the following deficiencies were observed :-

- 01. The cost benefit ratio as per the latest guideline of MoEF has not been submitted.
- **02.** The purpose-wise breakup of land should be given, as per the land use for various structures to be installed while laying the gas pipe line and the corresponding forest land involved in diversion.
- **03.** The land schedule showing forest land, GM jungle Jhari and non-forest land authenticated by revenue official is to be submitted.
- 04. The FRA Certificate along with the settlement of rights has to be submitted.
- 05. No objection certificate of GM Jungle Jhari obtain from DC, Chatra should be submitted.
- 06. Since, it is linear project, all the map (16"=1 mile) of the village falling in the project has to be submitted (involving both forest & non forest land). However, it was found that map of nine villages namely Bengwatai, Gue, Kolhaiya, Rajpur, Burigara, Polpol, Sinduari, Kanhakhurd and Chainpur village containing forest lands/Jungle Jhari land

- were also not submitted. The maps of all the village should be arranged serially and submitted, so that the verification can be done.
- 07. DGPS map of forest land to be diverted (both in hard and soft copies), in shape file, kml file is to be submitted. Although one copy of your proposal has been sent to RFO, Rajpur for joint field verification with your staff and enumerations of trees to be felled as per the direction of PCCF cum Executive Director, Wasteland Development Board, Ranchi received vide his memo no. 67 dt. 16-01-2018 but till date no one from your side appearred for joint verification and tree enumeration.

So, the proposal in 08 copies is being returned back with a request to resubmit it after necessary corrections in it, after which a date for inspection by undersigned will be given.

Please treat it urgent.
