

Sir,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. On scrutiny of the proposal, the following has been observed.

- a) Since, the instant project is a non-site specific in nature, detail justification for locating the project in the forest area giving details of the alternative non-forest area examined and reasons for their rejection has not been furnished with the proposal.
- b) The State Govt. has not furnished the trees enumeration list in respect of non-forest land involve in the project.
- c) The concerned DFO has not uploaded the KML files, SoI Toposheet, DGPS map of proposed CA/Addl. CA areas and CA/Addl. Scheme in Parivesh web portal.
- d) The user agency has not submitted the KML/shape file of non-forest land/degraded forest land identified for CA/Addl. C.A. and entire project area with the proposal.

It is therefore requested to furnish the above information to this office for further processing of the proposal.
