Sub: Diversion of 0.0013 ha of forest land for approach road to M/s Jain Bamboo and Wood Works (Saw Mill) Situated at village Bhunga on Hoshiarpur Road to Dasuya Road, km 22-23 LHS, Tehsil Bhunga and under Forest Division and District Hoshiarpur, Punjab. (online proposal no. FP/PB/Approach/146580/2021)-regarding.

महोदय, मुझे आपका ध्यान उपर्युक्त प्रस्ताव की और दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.0013 हेक्टेयर वन भूमि की मांग की गई है|

- प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे:
 - i) NOC from Punjab Pollution Control Board.
 - User agency had applied for FC clearance on 30.08.2021 and violation report was issued on 22.09.2021. This fits in the case, where the proposal under FC Act is under consideration and forest land is diverted before grant of FC. Hence, the State Govt will initiate disciplinary action against official concerned as per provision of 1.21 (ii)c and will prosecute the User agency for violation under local act of the State for unauthorised use of forest land without the permission of the State Authority as per 1.21 (ii)d of the Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines and clarifications), 2019 of MoEF&CC. A report for action taken needs to be submitted.
 - As per DSS report:- The name of the proposed CA site is Chak Sadhu (Chak Sadhu PF 20 ha Polygon for 19 ha CA land bank for FCA 1980 cases) in Hoshiarpur Range of Compartment no. H.B. No. 503. The total area of the block feature/KML is approx 20 ha out of it in approx. 16 ha seems to be available for the new target plantation. The uploaded KML seems to be shifted from the ground feature. This is large area for 100 plants. Need to provide specific KML dedicated for this project to fulfill the target plantation.
 - iv) Need to revise DGPS map and upload again on the portal because legend/index in the DGPS map is not matching with KML. In DGPS map strip in green color shown as land proposed for the forest diversion but in KML SG/UA provided entry/exit KML.
 - Delete all old and irrelevant documents from online portal part-I & II. Need to upload only relevant documents.
 - Layout plan needs to be approved by the competent authority and countersigned by the DFO concerned.

 - Viii) Approximate distance of the proposed site for diversion from boundary of forest (in km.):10. This needs to be corrected.
 - Penal NPV needs to be removed from the CA scheme, as this will be decided by the MoEF&CC in view of latest guidelines from Ministry. Accordingly, all documents, where Penal NPV has been mentioned, needs to be modified.
