Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.24 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarifications are still required to be submitted:

- (i) Correction of component-wise breakup of forest land at B.2.4 of Part-I to be submitted. It should match with the area mentioned under diversion proposal i.e. 1.24 ha for forest and 1.16 ha non-forest land.
- (ii) Administrative approval along with the covering letter from component authority to be submitted.
- (iii) Correction of no. of trees to be felled in CA Scheme as per Part-II, column 4 (ii).

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.





