विषय

Diversion of 1.5447 ha of forest land in favour of HPPWD for the construction of PHC Kainchi Nehra to Nagadhar via Growth road within the jurisdiction of Rampur Forest Division, District Shimla , Himachal Pradesh-reg.

सन्दर्भ:

Online Proposal No. FP/HP/ROAD/144151/2021 received on 18.08.2023

महोदय,

उपरोक्त विषय के संबंध में मुझे यह कहने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमी पाई गई है। अतः राज्य सरकार निम्न बिंदु पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके :-:-

- In Part-1, A -3 (xvii) the name mentioned in the authorization letter does not match with details of the person making the application.
- The state Govt needs to provide Administrative approval/financial sanction for the Proposed stretch from the competent authority along the approved DPR which needs to be uploaded.
- The KML uploaded under column C of Part-I online required correction on the following points:-
 - From the KML it is observed that the end point of the proposed alignment is being proposed to facilitate individual household/orchard. As Such, the concerned DFO is requested to kindly inspect the proposed alignment and provide his input regarding the aim and need of the road.
 - A fresh KML of the instant proposal needs to be provided in the polygon form of the diversion area as the proposed area for diversion is **3.8319 ha**, while the calculated area is **2.3 ha**
 - The KML file of the project site uploaded, doesn't have clear demarcation for forest/ non-forest areas. Hence, the KML file clearly indicating Forest/ Non-forest areas needs to be uploaded
 - The Alternative examined, needs to be marked on KML.
- As per the Short narrative of the proposal the length of the proposed road mentioned is 3.146 Km. However, as per the KML uploaded the total length of the proposed road is found to be **6.60 km**. Therefore, the State Govt needs to review the length of the proposed road and accordingly re-submit.
- A digital copy of the layout Plan in an appropriate scale which must include a legend and the proper dimensions of each component, such as Carriageway, Paved Shoulder, Earth Filling, Drain, and Protection Work, as well as area-wise calculations

- and Forest/Non-Forest area in different colors duly authenticated by the concerned DFO's needs, be uploaded.
6. A complete Muck Management Plan along with Engineering Measures and Biological Measures for the effective management of muck generated duly authenticated by the concerned DFO needs to be uploaded.
 7. The Muck dumping site is proposed in forest land. Suitable non-forest land/private land may be explored for disposal of muck as the non-forest land/private land is also involved in the extant proposal Also, a separate list of trees standing in muck dumping sites may be provided/uploaded, if muck dumping is proposed in forest land
 8. NoC/Sale deed/Gift etc., for non-forest land acquired from private individuals, is required to be submitted
 9. A large number of trees (**135**) are proposed for felling. Therefore, possibility of reducing the number of trees to be affected may be explored or rationalization to be done in the layout of the proposal to reduces green felling. Further, a list of trees which are required to be retained may be provided
 10. UA shall submit an Undertaking duly authenticated by the concerned DFO that the recharge point of the seasonal streams and springs shall be taken due care from the disturbance, and sufficient measures shall be adopted to preserve the sources of these natural springs/streams and their flow
 11. As per the DSS of the CA site approx. 2.98 (ha.) is available for the new plantation/target plantation out of 3.1 (ha.). Through google earth images it seems that proposed CA site area approx. Approx 0.08 (ha.) is also passing/overlapping through the proposed project site and hence, needs to be verified. Need to revise CA area to fulfill the target plantation.
 12. The State Govt shall submit a certificate regarding the non-availability of suitable non-forest land for raising compensatory afforestation in the format specified under Schedule III as mentioned in the **Consolidated Guidelines And Clarifications Issued Under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 And Van (Sanrakshan Evam Samvardhan) Rules, 2023.**
 13. The Status of the CA site proposed by the State needs to be clarified, whether it is a Govt. Wasteland is declared as PF under HP Govt. notification, 1952, or it is notified as UPF/DPF under IFA 1927.
