Sir,

Kindly refer to the above online proposal of Government of Jammu & Kashmir on the above mentioned subject seeking prior approval of the Central Government for diversion of 14.5494 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above mentioned proposal of the Government of J&K the following information/clarification are still required to be submitted:

- (i) Correction be made under column A-1 (x) of part-I regarding "Total period for which the forest land is proposed for diversion".
- (ii) Village wise break-up of forest land is shown as NIL. Need to be uploaded correctly.
- (iii) Site suitability certificate for 29.099 hectare to be submitted.
- (iv) Layout plan with area calculation of forest land to be submitted.
- (v) Component wise break-up of Non-forest land is shown as 0. Need to be uploaded correctly.
- (vi) DSS/google earth shows that KML file of project site is not matching with DGPS map. Revised KML file of the project site be provided./uploaded.
- (vii) DSS/google earth that the total KML file of CA site is 29.09 ha out of it 15.4 hectare vacant space is available. Additional area of 13.69 hectare is required for target plantation.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
