Sir,

I am directed to refer to the State Government's letter No. FEE 111 FLL 2017 dated 02/02/2018 and to inform that as per the details given in the proposal the proposed area is 25 meters to 100 meters outside the boundary of Kolluru Mookambika Wildlife Sanctuary. However, as per the DSS analysis done by this office with the support of Software developed by Forest Survey of India, the area proposed for diversion comes under Mookambika Wildlife Sanctuary. The relevant maps are also enclosed. It is, therefore, requested to verify whether the proposed area for diversion forms part of Kolluru Mookambika Wildlife Sanctuary.

In case the area falls in the wildlife sanctuary, then the permission of Standing Committee of National Board for Wildlife is required for consideration of the proposal under Forest (Conservation) Act, 1980.
